The inspection report and your subsequent responses for the inspection of West Coast Pharmaceutical Works Limited, Nr. Bhagwati Glass Factory, Opp, Jogni Mata Temple, Dennis Chem Lab, Vadaswami Side Road, Chattral-Vadaswami Road, Tal. Kalol, Dist. Gandhinagar, Gujarat-382740 India conducted by the ZAZIBONA Inspection team represented by Beatrice Kabaso - Lead (ZAMRA) and Ms. Martha Mwatseteza - Co Inspector (MCAZ), 17th and 19th to 22nd November, 2024 to verify compliance with current Good Manufacturing Practices (cGMP) refers.

It is confirmed that the inspection covered the following areas only:

- a) General Oral Solid Dosage Forms and Oral powders
- b) Liquid preparations
- c) External preparation



At the conclusion of the inspection the following resolutions were made:

1. GMP Status

Based on the areas inspected, the people met, and the documents reviewed; and considering the findings and the deficiencies listed in the inspection report, and the company's responses, the manufacturer, West Coast Pharmaceutical Works Limited, Nr. Bhagwati Glass Factory, Opp, Jogni Mata Temple, Dennis Chem Lab, Vadaswami Side Road, Chattral-Vadaswami Road, Tal. Kalol, Dist. Gandhinagar, Gujarat-382740India, **was found operating at an acceptable level of compliance** with the WHO principles and guidelines for Good Manufacturing Practice of pharmaceutical products.


2. Validity
